AGREEMENT, RELEASE, INDEMNIFICATION, COVENANT NOT TO SUE, AND WAIVER OF LIABILITY **(READ CAREFULLY BEFORE SIGNING)**

By signing below, I agree to abide by all of the Club Policies and Range Rules of Prairie Grove Gun Club, LLC d/b/a Prairie Grove Shooting Sports Complex (hereinafter, "Prairie Grove"), and I represent that I understand all of these rules, and was given the opportunity to ask for clarification of any of the rules before signing this Agreement. I understand that Prairie Grove reserves the right to eject from the property and the premises any individual who violates any of the Club Policies and Range Rules of Prairie Grove or otherwise acts in any unsafe manner as determined by Prairie Grove. I agree to peaceably leave the property and the premises of Prairie Grove if so ejected. I warrant and represent that I have not been convicted of a felony, I have not been convicted of a misdemeanor crime of domestic violence, and I am not under any other legal disability preventing me from lawfully possessing a firearm. I consent to all audio and video recording of me while I'm on the property and the premises of Prairie Grove.

In consideration of the acceptance of my participation directly or as a spectator, observer, range safety officer, match safety officer, volunteer, or in any other capacity whatsoever in any activity, class, lesson, competition, practice, demonstration, use of any clay target range(s) and/or facilities, use of any firearm range(s) and/or facilities, use/rental of any firearm, use of the club house and/or any other building or structure, use of any shooting stand(s), use of any vehicle(s) and/or equipment and/or tools, or any other use of any of the facilities whatsoever of Prairie Grove (hereinafter, collectively, "Activity"), I AGREE TO ASSUME THE RISKS incidental to such participation and, on my own behalf, on behalf of my executors and administrators, I RELEASE, INDEMNIFY, HOLD HARMLESS, COVENANT NOT TO SUE, AND FOREVER DISCHARGE the Released Parties defined below, of and from all liabilities, claims, actions, damages, costs or expenses of any nature arising out of or in any way connected with my participation in any such Activity and/or my failure to wear eye protection or ear protection during any such Activity. The Released Parties are Prairie Grove Gun Club, LLC; SSSF Sporting Properties, Inc.; Scholastic Shooting Sports Foundation, Inc; each of the foregoing entities' respective members, shareholders, officers, directors, employees, safety officers, volunteers, agents, representatives, attorneys, insurers, successors and assigns; and each of the foregoing entities' respective parent, related, affiliated and subsidiary companies. I expressly understand that the Release, Indemnification, Covenant Not to Sue, and Waiver of Liability provisions of this Agreement clearly and unequivocally include and apply to any claims based on the negligence (whether active or passive), ownership of any dangerous instrumentality, ownership of the premises, action or inaction of or by any of the above Released Parties, including, but not limited to, claims for bodily injury, death and property damage or loss of any kind suffered by me as a result of such participation in any Activity. Additionally, I further agree to indemnify and hold the Released Parties harmless from all liabilities, claims, actions, damages, costs or expenses of any nature arising out of or in any way connected with my participation in any Activity which results in the personal injury or death of anyone whatsoever, or loss or damage to the property of anyone whatsoever (including the loss of use thereof).

This Agreement shall be governed by the laws of the State of Missouri, and any legal action arising out of my participation in any Activity, or any litigation relating to the enforcement of this Agreement shall be commenced exclusively in the state or federal courts having jurisdiction over Boone County, Missouri.

In entering into this Agreement, I hereby grant the Released Parties a limited power of attorney and authorization to obtain, at my cost, any and all emergency medical treatment that I may need as a result of participation in any Activity. For the purposes of this Agreement, emergency medical treatment means medical care or treatment necessitated by a sudden, unexpected situation or occurrence resulting in a serious medical condition demanding immediate medical attention. However, I release, indemnify, hold harmless, covenant not to sue, and forever discharge the Released Parties of and from all liabilities, claims, actions, damages, costs or expenses of any nature arising out of or in any way connected with the exercise or the failure to exercise such limited power of attorney and authorization, whether negligent or otherwise.

I expressly agree that this Agreement is intended to be as broad and inclusive as permitted by law, and that if any provision of this Agreement is held illegal, invalid or otherwise unenforceable, the enforceability of the remaining provisions shall not be impaired thereby, and such invalid part, term or provision shall not be deemed part of this Agreement. I further agree that any ambiguities in this Agreement shall not be construed in favor or against any party by virtue of that party having drafted the Agreement. No remedy conferred by any of the specific provisions of this Agreement is intended to be exclusive of any other remedy, and each and every remedy shall be cumulative and shall be in addition to every other remedy now or hereafter existing at law or in equity or by statute or otherwise. The election of any one or more remedy hereunder shall not constitute any waiver of the right to pursue other available remedies.

I understand that, as part of any Activity, my photograph may be taken and I hereby consent to the publication of my likeness by any of the Released Parties or any other person, firm or corporation, in any form or in any kind or type of media whatsoever.

I certify that I am eighteen (18) years of age or older. I expressly understand that the aforementioned Activity may include the discharge of firearms and the firing of live ammunition. I agree that I will wear appropriate eyesight and hearing protection at all times while on any firing range. I further certify that I have completely read the foregoing and I expressly agree to all of the provisions of this Agreement.
